The Maharashtra State Biodiversity Board seeks application for the following types of fellowships from eligible candidates, who are Indian citizens and have requisite qualification and experience:

1. Biodiversity Project Fellowship (anywhere in the State):

Eligibility: Candidates must have Post-graduate degree (M.Sc.) in Botany, Biodiversity, Life Science, Ecology or Biosystematics with consistent good academic records (50% marks in case of SC/ST or 55% in case of others), and proficiency in Marathi and English.

Desirable: Proficiency in field taxonomy, relevant database & GIS.

Age limit: 30 years as on 01.01.2017 with applicable age relaxation

Fellowship: ₹20,000 per month + admissible HRA as per rules. Suitable candidates may be considered for higher fellowship of ₹23,000 per month and ₹25,000 per month, respectively.

2. Junior Biodiversity Fellowship (anywhere in the State):

Eligibility: Candidates must have Post-graduate degree in any of subjects stated above with the proficiency, and have successfully completed NET (National Eligibility Test) approved by UGC-CSIR.

Age limit: 30 years as on 01.01.2017 with applicable age relaxation

Fellowship: ₹25,000 per month + admissible HRA as per rules.

3. Emeritus Biodiversity Fellowship (At Nagpur and Pune):

Eligibility: Candidates must be Ph.D. in any of subjects stated above, and acknowledged experts in scientific research in plant/ animal taxonomy prior to his superannuation from university, institute, or reputed research organization.

Fellowship: ₹31,000 per month for period up to two years or up to the age of 70 years, whichever is earlier. Honorarium of ₹1,500 per day will be admissible in case of short-duration of project/work.

1. Biodiversity Project Fellowship (anywhere in the State):

Eligibility: Candidates must have Post-graduate degree (M.Sc.) in Botany, Biodiversity, Life Science, Ecology or Biosystematics with consistent good academic records (50% marks in case of SC/ST or 55% in case of others) and proficiency in Marathi and English.

Desirable: Proficiency in field taxonomy, relevant database & GIS.

Age limit: 30 year as on 01.01.2017 with applicable age relaxation

Fellowship: ₹20,000 per month + admissible HRA as per rules.
